- Developmental Disabilities **Consumer Directed Community** Supports (DD-CDCS)
- Community Access for Disability Inclusion (CADI)
- Brain Injury (BI)

Services are offered through a contract with Hennepin County for individuals whose County of Financial Responsibility is Hennepin. In some cases, we can continue supporting individuals who move outside the county, depending on their waiver services.

Please note: We are not contracted for the Community Alternative Care (CAC) or Elderly Waiver (EW) programs.

To receive Waiver Case Management through Reach for Resources, you must be enrolled in one of the eligible waiver programs (DD, DD-CDCS, CADI, or BI) and live in either Hennepin or Ramsey County.

- 2. Request Reach for Resources as your Case Management provider.
- 3. Once approved, we'll connect you with a Case Manager and begin the planning process.
